**General Release of Liability**

**COVID-19 Release**

*While Music at the Red Door Kids' Community Music Camp staff and volunteers have designed camp with many safety and preventative measures, it is impossible for us to guarantee that a child or his/ her household members will not become exposed to or infected by COVID-19 as a result of the child's camp participation, because there is risk involved in all contact between people of different households during the pandemic. By signing this release, the parent/guardian agrees not to hold the camp or anyone who is working for or participating in the camp responsible should a COVID-19 exposure or infection occur at camp.*

I, this child's parent/guardian, understand that Music at the Red Door's Kids Community Music Camp has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 at camp.
